Drawings prepared by Architect or Architect's professional consultants that may be relied upon by Contractor, pursuant to the conditions of the contract between the Owner and Prime Contractor, are limited to those printed drawings that are signed and sealed by the Architect or the Architect's professional consultants and are identified as Contract Documents in the Agreement between the Owner and the Prime Contractor, subject to any approved changes thereto. Files of text, data, graphics or other information transferred via FTP download are not Contract Documents and are furnished by the Architect hereunder solely for the convenience of the Contractor and for the limited purpose stated above. Any information or data obtained or derived from such electronic files will be used at the Contractor's sole risk. The Contractor is responsible for field verifying all measurements as well as coordination with all respective trades.

The Architect's title block or other information identifying the Architect or the Architect's professional consultants has or should have been omitted from files downloaded via FTP and this Agreement grants no right to reproduce or otherwise utilize such information.

Under no circumstances, shall the furnishing of files via FTP download, under this Agreement, be deemed a sale of a product. Architect makes no warranties, express or implied, in agreeing to furnish files via FTP download to Contractor.

Contractor understands that data stored on electronic media and in electronic form can deteriorate or be modified inadvertently and that errors and anomalies can be introduced into the data from the use of software application packages, operating systems, or computer hardware differing from those used by the Architect or the Architect's professional consultants. Contractor acknowledges and assumes all such risks.

Contractor also recognizes that changes or modifications to the Architect's drawings or other instruments of service, including but not limited to files of text, data, graphics or other information downloaded via FTP or transferred otherwise, which are introduced by anyone other than the Architect, may result in adverse consequences which cannot be predicted or controlled. Therefore, and in consideration of Architect's Agreement to furnish the above described information or data via FTP download, Contractor agrees to the fullest extent permitted by law, to indemnify and hold Architect and Architect's professional consultants harmless from and against any and all claims, liabilities, losses, damages or costs, including but not limited to reasonable attorney's fees, arising out of or in any way connected with the conversion, modification, misrepresentation, misuse or reuse, by Contractor or others, of information and data furnished by Architect under this Agreement.
